

In the video, Dr. Newman describes the shrewd effort to win the hearts and minds of our middle- and high-school children and grandchildren in their classrooms by getting major publishers of history and geography textbooks to include content that enhances Islam, while demeaning Christianity and Judaism. He tells what CFNS is doing about it - and what you can do as well! As many of you will remember, during two years of research which began in mid-2008, a CFNS Task Force uncovered almost 250 fully referenced quotations and excerpts in Islam-biased textbooks being used in Florida and nationwide that exemplify their Islamic slant. This Task Force is still at work, currently vetting later editions of these textbooks, as well as new ones that suffer from the same biases.

New Task Force Formed to Investigate Textbook Publisher Pearson PLC. The U.S. elementary-high school textbook market currently generates about \$6+ billion in sales. Three major publishers account for approximately 70% of it; and, Pearson, based in London, has the lion’s share of that. Pearson seems to produce most of the Islamist-biased textbooks. It has been on the receiving end of allegations, accusations, innuendoes, inferences, and the like, all of which are aimed at connecting them to the agenda of radical Islamist organizations. However, irrefutable evidence of such a nexus is still unavailable. The mission of the CFNS Task Force is to investigate Pearson to find out if such a relationship does exist; and, if it does, to expose it. CAIR Task Force Now Beginning Work on Second Edition of CFNS Book! Our recently published book, detailing every frivolous lawsuit brought or threatened by the Council on American-Islamic Relations, including all attempts at intimidation and extortion, against individuals, organizations, government and businesses throughout North America, has been received by every Senator and Member of Congress. Our book is the first of its kind to expose this dangerous organization for what it truly is. But CAIR continues its campaign of lawfare and intimidation! It presents itself as mainstream and moderate, claiming to seek nothing more than equality, civil rights and full societal participation for Muslims. It is headquartered on Capitol Hill in Washington, D.C. As readers of our first book will learn, CAIR's reality is far from this false image it tries to project. In fact, CAIR is a seditious and subversive organization operating within the United States and Canada as a direct operational extension of the radical Islamist Muslim Brotherhood. It regularly engages in strong-arm tactics to stifle free speech on Islam-related issues, and has also labored to Islamize the workplace. A Stellar Seminar Series in 2013/14! Record attendance and a series of top speakers characterized this past season's five CFNS seminars. In February of this year, CFNS Chairman, Dr. William Saxton welcomed Shoshana Bryen, Senior Director of the Jewish Policy Center in Washington, D.C. (see photo). Her topic was "Iran Rising: Impact On Israel Security And U.S. Support." Many of the approximately 130 attendees felt this was one of CFNS's finest seminars. Mrs. Bryen delivered a detailed and articulate overview of the relationship between the U.S. and Iran, including information not widely known or publicized.

This past November, we hosted former Department of Defense senior security policy analyst Michael Maloof who gave us a shocking report on radical Islam in the Caucasus, employing some dramatic Chechen terrorist training video. Then, in December, former CIA case officer Fred Rustmann revealed his experiences in the collection of foreign intelligence from human and technical assets during his fascinating 24-year career in many different parts of the world. Seminar participants were able to enter a secret world into which few have access.



To open the 2014 seminars in January, Dr. Peter Leitner, CFNS's co-Founder and Research Director, spoke about the use of lawfare and intimidation being practiced by the insidious Council on American-Islamic Relations (CAIR). His presentation was similar to what we presented to lawmakers and the media in Washington when we released our CAIR book on Capitol Hill in late November.

In March, CFNS Members and their guests had the opportunity to learn about the frightening, but all-too-real threat of information warfare being used by radical Islamists against the United States. The presenter, Kenneth E. deGraffenreid, is a Distinguished Fellow in Intelligence Studies at the American Foreign Policy Council. For over 40 years, deGraffenreid held leadership roles as a writer and teacher in the areas of strategic defense and intelligence policy and operations; counterintelligence and protective security; continuity of operations; and, infrastructure, cyber, telecommunications and information protection.
